Delivery Date to the Museum: April 20th, 2024 – May 4th, 2024

Theme: Conexiones/Connections; Size: 12" x 12"

Exhibition Date: May 11th to June 22nd

Unsold art quilts must be picked up June 26th, 2024 – July 6th, 2024

The focus on our May challenge, “Conexiones/Connections,” is on how the creative spirit connects ideas and they become interwoven.

We would love to help you find a forever home for your artwork. VMOTA will showcase your Art Quilts at our museum, pricing each quilt at \$125, \$175, \$250 or mark NFS (Not for Sale). *Artist Consignment Rules apply for all sales. Please see below.

Per VMOTA Agreement: (Please initial each line agreeing to the terms and conditions)

Delivery/Return of Artwork. To ensure your piece is properly received and displayed, the Artist is responsible for delivering/shipping the artworks to VMOTA, and for the costs of shipping and insuring the artworks during transit to and from the museum, in accordance with the following procedure:

_____ I am committed to hand-delivering my artwork to VMOTA in exhibition-ready condition by May 4th, 2024. In the event that my artwork does not sell, I am committed to picking up my piece by July 6th, 2024.

-OR-

_____ I am committed to shipping the artwork, in exhibition-ready condition, to arrive at the museum by, May 4th, 2024, while following the remaining steps:

_____ 1. This delivery must include **all PREPAID/PAID** shipping label(s) (including insurance) placed in an **ENVELOPE** taped to the inside of the shipping carton(s), which will be used to return the artworks to the Artist. (Note: we cannot accept shipping account numbers as a substitution for a return label.)

_____2. Visions Museum is **NOT** responsible for incorrectly produced, misplaced, stolen, lost, or improperly addressed return shipping labels.

_____3. Artist will ensure that work is delivered during the museum's open hours.

_____4. If the Artist does **NOT** include the required/correct return shipment label(s) for each piece of work, VMOTA is **NOT** responsible or liable for the return of the artist's work(s) **UNTIL** a return shipping label(s) is provided to the museum - (agarcia@vmota.org). VMOTA will hold artist's work until July 6th, 2024, if a return shipping label is not provided. After the deadline ends, the artist agrees to their work(s) being donated to Visions Museum of Textile Art.
